Meeting brought to order at 10:45am. We began the meeting with Ben Grove. Ben will talk about the Virginia Tech Foundation. Foundation is the organization the receives and manages money. The minimum to create an endowment is 25,000. This is for simply support of the program. No minimum for operating accounts. This applies to your units too. Amanda Lucas will handle these. If someone ask you for a determination letter proving you are non-profit you would talk with her. An endowment is set up to reserve that designated sum of money.

When you create the endowment there is an agreement that comes along with it that governs the spending of that account. An operating account does not have a governing agreement. Your revenue actually shows up as revenue to the Virginia Tech Foundation. The endowment amount will move up again. It is quicker than a state minutes/EA account.

Questions- Will the foundation handle most of our VEAFCS treasurer's responsibility?

Are there any restrictions that the funds can be used for? There is a user guide which specifies restrictions foundation put in place to offer more flexibility however you still have to justify and turn in receipts and so forth.

Is the operating fee based in and out? No maintenance fee's, new gift money one time 7% reinvestment fee, collecting dues and registering for conferences have no fee-Amanda Lucas in the contact

Brian recommends opening a foundation for your FCS operating expenses, can ask for gifts to make to the foundation and designate your local account. There is an ease with working with the Foundation, as long as you stay within those boundaries. University policy 1200 says it must be approved by Ben's office. Realize there is an approval process. Send a quick e-mail to Ben's office explaining what you are going to do.

Do not e-mail about foundations 48 hours before your deadline. If we set this up, we can have treasurer and Brian can sign off on the requests. We will share the information we the rest of the FCS body in October 9-10, and get back with Ben in November. Pegi and Jeanie joined us by phone.

Brian expressed his appreciation for cards and thoughts. Brian reiterated how Galaxy will strengthen extension agent and create opportunities for leadership. He also commended extension agents that will be attending. Cristin and Karen represented our FCS group with the Dean and Ag Econ. Brian feels positive about the relationship with Ag Econ, and the expectations of the position. If we don't get what we need but let's not let it fester. If we start working in the very beginning this will promote a good partnership. The job will be advertised in the Spring for the Family Financial Management Specialist. He hopes the position will remain in Liberal Arts. Hopefully we can get the position as an Associate Specialist. Cristin and her team are putting a proposal together now. As soon as it gets funded, the position will go out. It will be competitive. Alan and Ed are open communicators, so don't be afraid to voice your questions. Your professional association is another voice collectively.
