RULES FOR PARTICIPATION:

1. All participants must be bona fide 4-H horse project members. All equines present for the clinic must be the 4-Her's declared project animals, registered with their respective Extension Unit, and part of their Horse Project Record.
2. Participants must meet all county and state 4-H regulations for entry to the State 4-H Horse Shows.
3. Any **incomplete applications** will be returned and applicants not accepted.
4. Evaluation Requirements:
 - Participants must be prompt and be ready to begin at the appointed time. Once registered, your riding start time will be emailed to you.
 - Participants must come to the clinic with tack that they will be using at the State Show.
 - Clean, workmanlike clothing is appropriate. You do NOT have to wear your show attire.
 - Horses must be groomed and turned out for their appropriate show division. Braiding is NOT required.
6. The number of participants will be limited to 18 horse/rider combinations.
7. All 4-H Covid-19 Protocols are to be followed at all times.

- 4) **PAYMENT:** \$30 Payable to NDHC
- 5) **DEADLINE:** Entries must be postmarked/emailed by **MAY 15, 2021.** Late entries MAY be accepted if there is room after all entries are received.
