DETAILS: Each rider/horse will have a private 1 hour dressage session with the clinician. The session will begin with 30 minutes of warm up and flat instruction and coaching. The student will then perform a dressage test of their choosing. The clinician will work with them on fixing aspects of the test and give coaching and guidance. The student can then ride the test again to make the changes discussed.

Sign up for a 1hr slot each hour on the hour from 4-8pm Saturday, June 25th or Sunday, June 26th. Cost to 4-H Participants \$35 per time slot.

NUMBER OF PARTICIPANTS: There are 8 slots available. Please sign up for 1 slot per horse/rider combination. Each participant is welcome and encouraged to audit other riders for additional learning. There will be additional volunteers and youth to help each other learn the dressage tests before or after your time slot.
