RULES AND REGULATIONS

- **1.** Sprouse's Corner Ranch or Heartland Horse Heroes, show sponsors, employees, and other staff members affiliated with the Horse Show will not be held accountable for any loss or damage to animals, spectators, or personal property.
- **2.** The show committee reserves the right to cancel, combine, or divide class(es) as necessary.
- 3. Show personnel have the right to excuse any person or horse that is endangering spectators or show exhibitors.
- **4.** Judge's decision is final.
- **5.** All headgear must be in good operating condition and must be ASTM approved for equine activities. All riders under the age of 18 are required to wear a helmet.
- 6. All entries must have a negative coggins test
- **7.** A 2 minute gate call and a 5 minute tack change will be enforced.
- 8. Scratches and adds to classes must be made 2 classes before, no exceptions.
- **9.** No alcoholic beverage or drugs allowed on premises.
- 10. All dogs must be on a leash.
- **11.** No stallions in the 4-H qualifying show on June 16.
- **12.** No riders under the age of 9 may show in the June 16 qualifying show in classes where they have sole control of the horse, due to 4-Hinsurance restrictions.
- 13. JACKPOT payout is 75% of entry fees for 1st, 2nd and 3rd place winners plus ADDED MONEY!

Divisions:

Walk/Trot Hunter 1, 2, 3

Open to all amateur riders, horses and ponies that are not ready to show at the canter. Horse/Rider combination may not cross enter to any canter or jumping class.

Short Stirrup 4, 5, 6

Open to children 12 and under. Trotting permitted. Four fences at 18".

Beginner Hunter Horse/Pony 7, 8, 9

May not show in any other over fences class at the same show (except Hunter Hack).

Youth Hunter Pleasure 10, 11 12 **Adult Hunter Pleasure** 13, 14, 15

Pleasure Pony 16, 17,18

Ponies 14.2 and under, Junior riders.

Low Hunter 23, 24, 25

Open to horse or ponies, fences 2'

Schooling Hunter 26, 27, 28

Open to horses or ponies ridden by any age rider., fences 2'6"

Coached 30, 37 a), 38, 39

Coach allowed in the ring and to give verbal assistance. Coach allowed to assist rider if safety is in jeopardy. Riders may cross enter to Lead line, Costume, In-Hand Trail and Model only.
