NO HORSE REQUIRED FOR INTRODUCTORY CLINIC

PURPOSE: To allow 4-Hers to test Level One and Level Two Driving Skills as a part of the requirements of the Virginia State 4-H Horse Program. Successful completion of these two levels will be required of all horse/driver pairs who have not competed together at a previous State 4-H Horse Show. There is no fee for this skills evaluation. The 4-H Qualifying Driving Clinic and Introductory Driving Clinic for those without equines, sponsored by High Meadow Farm associates and trainers, will follow the skills evaluation schedule, beginning at 1pm rain or shine for \$15/participant, with proceeds benefiting the VA 4-H Horse Program.

NUMBER OF SKILL EVALUATION PARTICIPANTS:

The number of skill evaluation participants will be limited to **12** horse/driver combinations. Start times will be staggered and scheduled between 9am and 12noon. Those accepted for the evaluation will be sent a time to arrive. ***No evaluations will be conducted after the clinic.***

RULES FOR THE 4-H SKILLS EVALUATION & QUALIFYING CLINIC PARTICIPATION:

1. All participants must be bona fide 4-H horse project members. All animals used in the skills evaluation must be their 4-H Project animals, registered with their respective Extension Unit and part of their Horse Project Record.
2. Participants must meet all county and state 4-H regulations for entry to State 4-H Horse Show.
3. Any **incomplete applications** will be returned and applicants not accepted.
4. Evaluation & Qualifying Clinic Requirements: Participants must be prompt and be ready to begin at the appointed time. Participants must come to skills evaluation and clinic attired and turned out as they would be for their discipline. As portions of the evaluation will be conducted on the ground, horses should be brought to the testing area in a halter. However, appropriate tack for the driving discipline must be brought along also.
5. Successful completion of Horsemanship Skills Levels One and Driving Skills Level Two are required for participation at the State 4-H Horse Show. Level one must be passed in its entirety. If participant fails any part of Level One they must retest on all Level One skills. With Driving Skills Level Two, any individual skills missed may be retested without redoing the whole level.
6. Applicants must provide copies of their **health form**, **equine waiver**, and **current coggins**.
7. Measurement of horse available upon request at the Evaluation/Clinic
