**RULES FOR PARTICIPATION:**

1. All participants must be bona fide 4-H horse project members. All equines present for testing must be the 4-Her's declared project animals, registered with their respective Extension Unit, and part of their Horse Project Record.
2. Participants must meet all county and state 4-H regulations for entry to the State 4-H Horse Shows.
3. Any **incomplete applications** will be returned and applicants not accepted.
4. Evaluation Requirements:
  - Participants must be prompt and be ready to begin at the appointed time. Once registered, your testing start time will be emailed to you.
  - Participants must come to the Evaluation with tack that they will be using at the State Show.
  - Clean, workmanlike clothing is appropriate. You do NOT have to wear your show attire.
  - As portions of the evaluation will be conducted on the ground, horses should be brought to the testing area in a halter.

6. The number of participants will be limited to 20 horse/rider combinations.
7. There is no fee for this testing session.

Once your entry is received, you will receive confirmation. Testing times will be sent to individuals once all entries are received and a schedule is completed.
- 2) **COGGINS:** Testing facility must have a copy of a current negative coggins for each equine participating in testing. Send the copy with your entry or bring it to the testing facility.
- 3) **DEADLINE:** Entries must be postmarked/emailed by **June 6, 2019**. Late entries MAY be accepted if there is room after all entries are received.
