1. HELMET REQUIRED FOR ALL PERSONS MOUNTED ON A HORSE AT ALL TIMES.
2. All participants will be required to complete a Virginia Cooperative Extension Equine Waiver at check-in.
3. Competitors must be a Virginia 4-H member in good standing. Extension Agent or Club Leader verification required.
4. **Virginia Department of Agriculture and Consumer Services require all horses on show grounds to have a current (within 12 months) negative coggins. No exceptions for any reason. You must have copy of test on hand.**
5. Show management reserves the right to add, cancel, or combine classes.
6. Goodwill and sportsmanship are essential for a fun and safe show. Management reserves the right to bar any exhibitor, owner, spectator or animal for inappropriate conduct.
7. No alcohol permitted on fair grounds or Buchanan Town Park property.
8. Virginia Cooperative Extension, The Town of Buchanan, show management, judges, any members, families, organizers, volunteers, property owners, employees assume no responsibility in case of loss, injury, or damage to persons, horses, or personal property for any cause and admittance and entries are accepted only on this basis.
9. A 2 minute gate call and 5 minute tack change will be enforced.
10. Entry Form must be completed and submitted prior to participating.
