RE: 2021 Block & Bridle Club Stockmen's, Livestock Judging, and Meat Evaluation Contests

The Block & Bridle Club at Virginia Tech has scheduled their 2021 Stockmen's and Livestock Judging contests via a VIRTUAL format, for Wednesday, March 3rd – Sunday, March 7th. At this time, the Meat Judging contests are being postponed with a date TBD, in hopes of being able to hold an in-person event later in the spring or early summer once gathering numbers are increased. The Stockmen's and Livestock Judging Contests will be VIRTUAL events that contestants will complete electronically using a laptop, desktop computer, tablet or iPad. Mobile devices such as cellphones may be used, but we cannot confirm the ability of those devices to show the full scope of classes and contest materials.

The contest platforms will open at 8:00 am on Wednesday, March 3rd and close automatically at 6:00 pm on Sunday, March 7th.

As the contest delivery mode has changed for 2021, please read this letter carefully to make sure you understand the technology requirements, additional divisions, and contest logistics.

There is no limit to the number of teams a unit or chapter can enter in any contest. For Stockmen's and Livestock Judging there are NOT separate 4-H and FFA contests, and youth are NOT allowed to dual enter – they must compete either as a 4-H member or an FFA member, but not both. Out-of-state teams and individuals are allowed to compete in both contests.

All Contests - <u>Contestant Eligibility</u>: All contestants must be enrolled in either the 4-H unit or FFA chapter that they represent in these contests. <u>Contestant eligibility will be verified</u> using 4HOnline and the State FFA enrollment records for all contestants.

AGE/DIVISION ELIGIBILITY – PLEASE READ – CHANGES FROM 2020 – <mark>ALL DIVISIONS WILL BE BROKEN ON</mark> <mark>BIRTHDATE/AGE</mark>

<u>Junior Contestants</u> are youth who have not had their 14th birthday prior to January 1, 2021 and also includes youth who will turn 9 years old by September 30, 2021.

<u>Senior Contestants</u> are youth who turned 14 years of age prior to January 1, 2021 and have not had their 19th birthday prior to January 1, 2021.

Directions for how to complete the entry form(s) and what information you will need to provide are included at the beginning of the form.

All contests and all contestant information will be submitted at this one link. Please have the following information available for each contestant prior to beginning the entry process:

- Name
- Date of Birth
- Any Assistive Services Requested (reader, interpreter, etc.)

Youth will be assigned to teams the week of the contest. Coaches will receive an email confirming entered/eligible youth names and asked to designate team members at that time.

You must submit the online Qualtrics form <u>AND</u> mail a hard copy of the completed form with your entry payment or proof of payment processing. This will help us confirm entries.

Stockmen's Contest – The stockmen's contest is a test of general knowledge of livestock production. The 12minute classes include a 20-25 question multiple choice quiz (100 points) – 24 minutes will be allocated for quiz completion; identification of feeds, equipment, breeds, and retail meat cuts (50 points each class); judging of hay, retail meat cuts, and classes of livestock (50 points each class); and questions about judging classes (25 points each class); One or more judging classes (livestock) may contain a scenario and performance data. Please be aware that we will have a nutritive analysis and scenario on the hay judging for senior contestants. Seniors will also complete feed usage, equipment usage, and breed descriptions. There will also be a group exercise for senior teams that members will complete as a team. It will be up to the team coach/teacher to determine how to best provide for the team to collectively complete the team problem, complying with current COVID restrictions and guidelines.

Contestants are allowed to use a simple 4-function calculators for the senior team problem and quiz (junior and senior). Only simple 4-function calculators will be allowed – contestants will be disqualified and lose access to the contest platform if they utilize search engines such as Google to look for information when answering questions or completing sections.

<u>Stockmen's Contest Eligibility</u> - Members who have previously participated in the National 4-H Skillathon contest are **<u>not</u>** eligible to participate in this contest.

This contest will be broken into two age divisions Junior and Senior, based on the ages and contestant's birthdate. Details are listed on page 1 of this letter.

Stockmen's Contestant Responses: All Stockmen's Contest Responses will be submitted using the link provided prior to the contest. There will be a separate link for each age division and coaches/contestants are responsible for completing the correct contest link applicable to each contestant. Completion of the wrong contest material will result in disqualification.

Each class (quiz, identifications, judging classes) will be timed and time begins when the contestant opens each class. Once a contestant has opened a class, they must finish in the time allotted and will not be able to log out and then log back into that same class. To accommodate students and school schedules, youth contestants will be able to log out, and log back in at any time during the "Contest Open" period and complete/finalize their contest. PLEASE REMEMBER – ONCE A CLASS IS STARTED, TIME BEGINS AND IT MUST BE COMPLETED BEFORE LEAVING THE PLATFORM. You will not be able to go back to a class or section after moving on to the next one.

Livestock Judging Contest – This contest will consist of eight classes of beef cattle, swine, sheep, and meat goats. Performance data may be provided for at least one breeding class in each species. Ten questions will be asked on 2 classes. Contestants may have to judge breeding or market classes of each species. Video classes will be used whenever possible, but still picture may also be used if necessary. Contestants will have 12 minutes to judge each class, and take notes for reasons, if applicable.

The livestock judging contest will be broken into four divisions – <u>these have been renamed</u>: Junior Non-Reasons Livestock Judging, Senior Non-Reasons Livestock Judging, Junior Reasons Livestock Judging, and Senior Reasons Livestock Judging. Junior Reasons Contestants will give two sets of reasons. Senior Reasons Contestants will give four sets of reasons. The Junior and Senior age classifications will follow the ages or academic grade level, and organizational membership as listed at the beginning of this letter.

<u>Livestock Judging Eligibility</u> - Members who have previously participated in the National 4-H Livestock Judging contest or National FFA Livestock Evaluation CDE are <u>not</u> eligible to participate <u>under that organization</u> in this contest.

<u>Livestock Judging Contestant Responses</u> - All Livestock Contest Responses will be submitted using the link provided prior to the contest. There will be a separate link for each of the four contest divisions as listed previously and coaches/contestants are responsible for completing the correct contest link applicable to each contestant. Completion of the wrong contest material will result in disqualification. Class placings for all classes will be submitted electronically, as will recorded reasons uploads for those junior and senior youth competing in the reasons divisions. Reasons uploads must be submitted within 12 hours of judging the final class, AND before the contest link closes at 6:00 pm on Sunday, March 7th.

Summary of Stockmen's and Livestock Judging Contest Details

<u>Meats Judging Contest</u> – Dates, times, and locations for the Meats Judging Contests, which serve as the State Contest for both 4-H and FFA, <u>have yet to be determined</u>. Those events are temporarily postponed with hopes of holding in-person contests later in the spring or early summer. If this does not appear to be feasible, we will proceed with a virtual event later this spring or early this summer. Because these are the State Meats Evaluation Contests for both 4-H and FFA, these contests will use the standard eligibility age/grade for the respective organization.
