SUBJECT: 2022 Shenandoah Valley Invitational 4-H & FFA Meats Judging Contest

We are grateful to once again resume the annual Shenandoah Valley Invitational 4-H & FFA Meats Judging Contest. The contest will be held Saturday, January 22, 2022 beginning at Rockbridge County High School at 8:30 AM. The contest is generously sponsored by Rockbridge Farmer's Co-op. The contest would not be possible without the partnership of Donald's Meat Processing, Buffalo Creek Beef and Rockbridge County Public Schools. We are planning this event as an in-person contest. However, due to the ongoing COVID-19 situation, this may be subject to change, with the event being postponed or moved virtual. If this occurs participants will be notified of changes as soon as possible. Masks are required for participation.

This contest should be regarded as a preparation contest for the Virginia state 4-H & FFA meats judging contest sponsored by the Block & Bridle Club. As such, all efforts will be made to make the contest as similar as possible. However, 4-H and FFA teams from outside of Virginia are welcome to compete. The contest will use the official 4-H/FFA Meat Evaluation Form #480-4. Registration fees will be \$5/contestant and \$10/lunch for a total of \$15/person. Coaches may also purchase lunch. Additional details describing the contest can be found in the accompanying
