GENERAL RULES & REGULATIONS

- Each exhibitor must be a 4-H or FFA member enrolled in a 4-H club or FFA chapter by January 1, 2022.** Exhibitors must be 9 years of age by September 30, 2022 to participate and not passed the age of 19 by December 31, 2022.
- Entry deadline for all departments – must be postmarked by April 30, 2022.**
Late entries will be accepted until May 7, 2022 but will incur a double entry fee.
 - Exhibitors will need to get their entry forms signed, attach copy of their Health History form and mail with their check payable to ‘Northern District Livestock Show’ to: Andy Anderson, NDLS Treasurer, 4489 Hoover Rd, Reva, VA 22735. Any returned check fees, bank fees, or other collection fees will be the responsibility of the exhibitor. **Entry fees are non-refundable.**
- The Northern District Livestock Show is open to exhibitors from the following counties: Albemarle, Alexandria, Arlington, Augusta, Bath, Caroline, Clarke, Culpeper, Fairfax, Fauquier, Fluvanna, Frederick, Greene, Highland, King George, Loudoun, Louisa, Madison, Orange, Page, Prince William, Rappahannock, Rockbridge, Rockingham, Shenandoah, Spotsylvania, Stafford and Warren.
- Gates will open at 7:00 am, all animals must stay on trailers until they have been cleared by a vet.
 - All SWINE entries must be weighed at the upper barn between 7 & 8 am and check in by 8 am.
 - Beef entries will be checked and steers and commercial heifers weighed in the middle barn at 8am. Beef entries must be checked in by 9am.
 - SHEEP entries must be weighed at the upper barn between 8 & 9 am and checked in by 9:00am.
 - DAIRY GOAT entries must be on the grounds and checked in by 9am.
 - MEAT GOAT entries must be on the grounds and weighed in starting at 10:30am.
- NO PERSONS OR ANIMALS WILL BE PERMITTED TO STAY ON THE GROUNDS OVERNIGHT.**
- Showmanship Class Ages are as follows:
 - Novice:** for exhibitors showing for the first time, and who are 12 years of age or younger on September 30, 2022.
 - Junior:** exhibitors 12 years of age and younger on September 30, 2022.
 - Intermediate:** exhibitors 13-15 years of age on September 30, 2022.
 - Senior:** exhibitors 16 years of age to 19 years of age on September 30, 2022 – no exhibitors may have reached their 19th birthday prior to January 1, 2022.
- Showmanship classes - if an exhibitor enters more than one species, they must enter at least one showmanship class. They do not have to participate in all showmanship classes. Whichever showmanship class they participate in, must be marked on their entry forms.



8. Exhibitors must show their own entries unless the exhibitor has more than one animal in the same class, or permission is given by the species committees. Substitute show persons must be eligible 4-H or FFA members with NDLS entries on-site and checked-in for any species.
9. All exhibitors must wear their exhibitor's number, clearly visible, while in the show ring. Number cards will be provided. Harnesses will not be required.
10. With the exception of those with disabilities, injury or when two (2) animals are in the same class the exhibitor must show each class entry. The second animal must be shown by another exhibitor the day of the show.
11. All entries must be the property of the 4-H or FFA member making the exhibit. Entries are accepted in good faith that feeding, management, and care of animals have been conducted as part of a 4-H or FFA project by the exhibitor.
12. Stalling will be available both in the barn and "off-the-trailer". Stalling assignments in the barn will be done at the discretion of the species committees. Parking assignments will be done at the discretion of the parking staff. In the case that all of the barn stalling is occupied, exhibitors will be expected to show off of the trailer. Exhibitors should indicate their preference for in-barn or off-trailer stalling on their entry forms.
 - a. Exhibitors choosing to stall in the barn should only put down the bedding they need. The bedding may remain in the barn at the conclusion of the show; however, the bedding must be scattered and not consolidated to one area of use.
 - b. Exhibitors choosing to stall and exhibit "off-the-trailer" are responsible for cleaning up **any and all** bedding that they may choose to put down on the grass; leaving the ground in the same condition as they found it.
 - c. All exhibitors, both those that stall in the barn and those that show off-the trailer, are responsible for cleaning up their own areas at the conclusion of the show.
 - d. Cattle, sheep, and goats will not be given pens, tie space only. Swine will be provided pens for stalling.
13. Show superintendents and/or species committee's reserve the right to eliminate any animal from competition that is not manageable and safe for public exhibition.
14. **Revised in 2022:** The show superintendents and/or species committee's reserve the right to disqualify any animal that has been fitted in an unethical manner. The following fitting practices/products are prohibited regardless of breed or division:
 - a. The addition of any hair or hair like substances, including false tail heads and false polls
 - b. The act of artificially filling animals internally, which would include stomach pumping, drench tubes, or any other methods
 - c. The cutting, tearing or gluing of the hide or underneath the hide or removal of tissue in an attempt to alter the shape of the animal



- d. The injection of any gas, solid or liquid under the hide to alter the normal
 - e. conformation
 - f. Any product/solutions/liquids administered internally or externally to alter the conformation of the animal. To include the use of steroids, illegal or unapproved growth promotants, and the act of artificially filling animals
15. Animals shall be under the control of exhibitors at all times without the aid of tranquilizers or other drugs. Dangerous or drugged animals will be disqualified and removed from show area.
16. All animals exhibited must be in good physical health. Any animal found with a disease that could be passed on to other animals will be removed immediately from the grounds. The veterinarian will check health of animals before unloading. The veterinarian will make the final decision. No health papers from any veterinarian will be accepted.
17. Any animal shown in purebred breeding classes must have registration papers present on the day of the show, except lambs. Lambs that are pending should have proof of both parents that are registered the day of the show. Papers will be checked prior to showing. A screening committee will verify the suitability of entries in any class.
18. All written complaints or suggestions should be directed to appropriate committee chair by close of the show.
19. Show chair has the right to add, delete, or combine classes.

GROUNDS

20. Vehicle operators will observe and obey designated parking areas.
21. Northern District Livestock Show and Culpeper Agriculture Enterprise will not be responsible for damaged or loss of personal property.
22. No pets allowed on grounds.

CLASSES

23. The order of showing and judging will be: Showmanship classes, followed by the other classes listed under each species. Being this is a one-day show; some shows will run concurrent with others.
- a. *Exhibitors are responsible for keeping track of show schedules and be in place for their classes; shows will not be held for tardy/absent exhibitors.*
 - b. *If an exhibitor enters more than one species at the show he or she has the option of participating in one showmanship or all that they enter. Each exhibitor is required to show in at least one showmanship class. The showmanship class must be marked on the entry form.*
24. Premium money, ribbons, and awards will be given the day of the show.



25. When classes are divided, money and ribbons will be awarded and the winners are eligible to come back in the championship class. It will be the decision of the show superintendents and/or species committee as to when classes are to be broken.

CODE OF CONDUCT

The Code of Conduct is an agreement, formal or implied, between the participants and the management of this show. Its purpose is:

- To ensure the overall well-being of animals exhibited.
- To ensure the use of commonly accepted practices in preparing and exhibiting animals for show.
- To maintain the intent and integrity of animal competitions for future generations.

All Adults and Youth should abide by the 4-H Code of Conduct.

Disciplinary action will result from any infraction of the above provisions and any one or more of the following actions may be taken depending on the severity of the infraction a determined by the show committee:

- Legal action
- Suspension of 4-H privileges
- Extension agent will be notified.
- Restitution
- Apology to those involved
- Reprimand
- May be asked not to return in the future shows.

BEEF SHOW RULES

1. See General Rules & Regulations for stalling information and fitting practices.
2. **An entry fee of \$25 per entry/head must accompany the entry form. Late Entries \$50/head entry fee.** See General Rules & Regulations #2 for entry deadlines. Entry fees are non-refundable.

HEALTH REQUIREMENTS

3. If heifer originated from a state **other** than Virginia, Pennsylvania, Maryland, West Virginia, or North Carolina, proof must be shown of negative Brucellosis (BANGS) vaccination and negative TB or current negative blood test within 30 days.

BEEF SHOWMANSHIP

4. Every exhibitor must enter the showmanship class - unless you are showing more than one species. **See General Rules & Regulations.**
5. Animals must be cleaned and well groomed.

FEEDER/MARKET STEERS

6. Beef feeder steers will be divided by weight classes.
7. Exhibitors must own their feeder/market steers by *March 1, 2022*.
 - a. Feeder/market steers are defined as those intended for show and sale by the fall of 2022.

PUREBRED HEIFERS

8. Purebred heifers will be divided into different breed classes. Four (4) or more heifers will constitute a breed division. If there are not 4 heifers to make a division, then heifers will show in AOB division. There is no limit on the number of heifers that can be shown in each breed, so long as the exhibitor does not enter more than two (2) animals per age class.
9. Purebred heifers must be entered on the Junior Purebred Heifer project entry blank. **A copy of the registration papers must be included with the entry forms. Registration papers are required the day of the show and will be checked by the barn manager.**
10. Tattoos must be legible and match registration papers. If not, must be shown in commercial class. If no registration papers are included with entry form and presented on the day of show then heifers will show in commercial class.
11. The date of sale as shown on the registration certificate will be the date that is used to determine eligibility of purchased heifers or a proper bill of sale.
12. All heifers must be the property of, in the care of, and registered in the sole name of the exhibitor by the following dates according to age and show classification:



- i. Senior Yearling Heifers: January 15, 2022
- ii. Early Junior Yearling Heifers: January 15, 2022
- iii. Late Junior Yearling Heifers: January 15, 2022
- iv. Summer Yearling Heifers: March 15, 2022
- v. Senior Heifer Calves: April 20, 2022

- vi. There will be five classes for each breed:

- vii. Senior Yearling Heifers: Calved 9/1/2020 - 12/31/2020
- viii. Early Junior Yearling Heifers: Calved 1/1/2021 - 2/28/2021
- ix. Late Junior Yearling Heifers: Calved 3/1/2021 - 4/30/2021
- x. Summer Yearling Heifers: Calved 5/1/2021 - 8/31/2021
- xi. Senior Heifer Calves: Calved 9/1/2021 - 12/31/2021

COMMERCIAL HEIFERS

13. Commercial heifer class will be shown based upon weight.



SWINE SHOW RULES

1. See General Rules & Regulations for stalling information and fitting practices.
2. **An entry fee of \$15 per animal must accompany the entry form. Late entries \$30/head entry fee.** See General Rules & Regulations #2 for entry deadline. Entry fees are non-refundable.
3. Hair Clipping: for show eligibility, hair length on the body (hams, top, sides and shoulders) must be at least one-half inch. Pigs with body hair length less than one-half inch are not eligible for the show.
4. All hogs must be identified with an ear tag.
5. All hogs originating from an out of state breeder must be from a pseudorabies free herd. Certification papers for out of state hogs must be presented to the show committee the day of the show or they will not be able to show. All hogs originating from a Virginia breeder are not required to show proof of pseudorabies certification.
6. Bring only the bedding you will need for your animals the day of the show. Penning will be done at the discretion of the barn managers. Pens must be cleaned out of person trash and belongings at the conclusion of the show. Bedding does not have to be removed, just scattered.

DIVISION 1 – SWINE SHOWMANSHIP

7. All swine exhibitors must enter the showmanship class unless you are showing more than one species the day of the show. **See general rules & regulations #4.**

DIVISION 2 – MARKET HOGS

8. All market hogs entered must weigh between 100 lbs. to 280 lbs. to be eligible to show in market classes.
9. Classes will be divided by weight, at the discretion of show managers.
10. Hogs weighing under 100lbs are eligible for feeder class. Feeder hogs are not eligible for Champion Drive.



SHEEP SHOW RULES

1. See General Rules & Regulations for stalling information and fitting practices.
2. **An entry fee of \$15 per animal must accompany the entry form. Late entries \$30/head entry fee.** See General Rules & Regulations #2 for entry deadline. Entry fees are non-refundable.
3. All lambs must weigh a minimum of 50lbs.
4. **All breeding sheep and market lambs must be slick shorn within two weeks prior to the show except wool sheep.** Wool breeds must have more than one inch of wool. All sheep must be shown clean and well groomed.
5. Each exhibitor is limited to a maximum of two (2) entries per class. Total head entered must not exceed 8 breeding sheep and/or 6 market lambs.
6. **Scrapie Tags are required for all animals including wethers. The tags will be the official scrapie tags with the farm number appearing. No metal slaughter only tags will be accepted. Purchased lambs from large breeders should already have these tags when purchased.**
7. Sheep may only be shown in one division (i.e. market, purebred, commercial, or wool).
8. While showing of the animal there will be no continuous lifting of the animal off the ground. This will lead to disqualification. This will be monitored during the show. **Animals will be treated humanely while they are at the show.**
9. Breeding animals will be shown off the following birthdates:
 - a. **Class 1** Junior ram lamb Born January 1, 2022 or after
 - b. **Class 2** Senior ram lamb Born prior to January 1, 2022
 - c. **Class 3** Yearling ram Between 1 and 2 years of age
 - d. **Class 4** Aged ram Two years or older
 - e. **Class 5** Junior ewe lamb Born January 1, 2022 or after
 - f. **Class 6** Senior ewe lamb Born prior to January 1, 2022
 - g. **Class 7** Yearling ewe Between 1 and 2 years of age
 - h. **Class 8** Aged ewe Two years or older

DIVISION 1 – SHEEP SHOWMANSHIP

10. All sheep exhibitors must enter the showmanship class unless you are showing more than one species the day of the show. **See General Rules & Regulations #4.**

DIVISION 2 – MARKET LAMBS

11. Only wethers or ewe lambs may be shown in this division. Wethers must be shown with no evidence of testicular tissue and be completely healed from castration.
12. Scales will be provided and lambs will be weighed on the day of the show to determine



final entries in the market lamb classes. Lambs will be weighed at the upper scales between 8 & 9 am.

13. Market classes will be divided by weight.

14. Ewe lambs shown in this division may not be shown in breeding classes.

DIVISION 3 – REGISTERED PUREBRED CLASSES

15. All sheep must be the property of, and registration certificates issued in the name of, the exhibitor.

16. Only lambs may be exhibited with registration papers pending, however, the certificate of registration of the sire and dam must be available the day of the show.

17. Breed divisions must have four (4) or more animals exhibited by two (2) or more exhibitors. If less, they will be shown in other purebred.

18. Each class entry to be shown by the exhibitor only, with the exception of disability or injury, or the exhibitor has two (2) entries in the class.

DIVISION 4 – WOOL SHEEP

19. Sheep in this division may be registered, grade, or crossbred. Sheep exhibited in this division may not be shown in any other division.

20. Wool sheep may be exhibited in full fleece, but all sheep must be clean and well groomed.

21. Sheep should be entered as fine, medium, long, or coarse wool (in the space designated for breed).

22. Wool classes will be judged in two sections: fine and medium wools, and long and coarse wools. Sections with fewer than four (4) animals will be combined.

23. The wool sheep classes will be shown the same as listed under purebred classes.

DIVISION 5 – COMMERCIAL SHEEP

24. Sheep in this division may not be exhibited in any other divisions.

25. The commercial sheep classes will be shown the same as listed under purebred classes.



MEAT & DAIRY GOAT SHOW RULES

1. See General Rules & Regulations for stalling information and fitting practices.
2. **An entry fee of \$15 per animal must accompany the entry form. Late entries \$30/head entry fee.** See General Rules & Regulations #2 for entry deadline. Entry fees are non-refundable.
3. Scrapie Tags are required for all animals including wethers. The tags will be the official scrapie tags with the farm number appearing. No metal slaughter only tags will be accepted. Purchased goats from large breeders should already have these tags when purchased. DAIRY varieties will be required to have a tattoo only, no Scrapie tag.
4. While showing the animal, there will be no continuous lifting of the animal off the ground. This will lead to disqualification. This will be monitored during the show. **All animals will be treated humanely while they are at the show.**
5. **Doe kids may be shown in the market section OR the dairy section, not both. Wethers cannot be shown in dairy classes.**

DIVISION 1 –GOAT SHOWMANSHIP

6. All goat exhibitors must enter the showmanship class unless you are showing more than one species the day of the show. **See general rules & regulations #4.**

DIVISION 2 –MARKET GOATS

7. Wethers or does may be shown in this division. Wethers must have evidence of castration present.
8. **All goats must be born on Oct 15, 2021 or after to be entered.**
9. Scales will be provided and goats will be weighed on the day of the show to determine entries in market weight classes. Minor weight adjustment may be made by the show chair to balance weight classes.
10. Market classes will be divided by weight, not breed.
11. Exhibitors are limited to **2 market goats.**

DIVISION 3 - DAIRY GOATS

12. Registered does will be required to present ADGA\AGS registration paperwork.
13. Dairy goat exhibitors are encouraged to wear Dairy Whites with closed toe shoes or boots and matching belt. Tank tops, halter tops and clogs are not acceptable.
14. Dairy goats must be dehorned.
15. Exhibitors limited to 10 dairy goat entries.
16. If less than four goats in a breed they will show in an All Other Breeds class.



Classes

- i. Milkers, under 2 years old
- ii. Milkers, 2 & 3 years old
- iii. Milkers, 4 years old and older
- iv. Junior doe kids born on or after February 1, 2022
- v. Intermediate doe kids born January 1–31, 2022
- vi. Senior doe kids born on or before December 31, 2021
- vii. Dry doe yearlings – over one year and under 2 years, never freshened
